A. Eligibility for Sl. No-1,2 & 3 :The minimum specific experience as a prime contractor in construction works of carrying, installation, laying, testing & commissioning of 33/11/6.35 KV Submarine cable or carrying, installation, laying, testing & commissioning of 33/11/6.35 KV underground cable under maximum 03(Three) Nos contracts successfully completed within the last 10 (ten) years, with a total value of Tk. mentioned as per tender document.

B. Eligibility for Sl. No-4 :The minimum specific experience as a prime contractor in construction works of carrying, installation, laying, testing & commissioning of 33/11/6.35 KV Submarine cable under maximum 03(Three) Nos contracts successfully completed within the last 10 (ten) years, with a total value of Tk. mentioned as per tender document.

C. Interested contractors must visit the construction site of off-grid area before submission of tender and must submit the "Declaration of Site Visit" on their letterhead Pad along with the tender. Tenders without the "Declaration of Site Visit" maybe rejected.
