This is an online Tender, where only e-Tender will be accepted in the National e-GP Portal and no offline/ hard copies will be accepted. To submit e-Tender, registration the National e-GP System Portal (<a href="https://www.eprocure.gov.bd">https://www.eprocure.gov.bd</a>) is required.

The fees for downloading the e-Tender documents from the National e-GP System Portal have to be deposited online through any e-GP registered banks branches up to **04.08.2019 at 17.00 PM**. Notice that according to ITT Clause No-4.2 maximum quantity of incomplete lines for BREB Enlisted Line Construction Contractors (LC) - Up to 300 KM, BREB Enlisted Provisional Line Construction Contractor (PLC) - Up to 100 KM, PBS Enlisted Permanent Mini Contractor - Up to 100 KM and PBS Enlisted Provisional Mini Contractor - Up to 100 KM are eligible and over is not eligible. Also according to ITT Clause No-15(i) required information must be fill up in prescribed Table. Otherwise submitted tender will not be considered for evaluation.
