The Tenderer(s) can participate either individually or in a Joint Venture / Consortium. In case of Joint Tendering, a prime tenderer must be designated by the JV members with whom contract will be signed. The prime tenderer and other partners must have current and valid enlistment under category of 1.4 with TGTDCL and / or any other company of Petrobangla and will be equally responsible for execution of the contract. The tenderer (any of the partner in case of Joint Venture) must have minimum experience of construction 4 (Four) kilometer long 10" or above diameter high pressure (300 psig or above) gas pipelines in a single or more (aggregated in length) on procurement, construction and commissioning and value not less than Taka 4 (Four) crore as proprietor / partner / Joint Venture / Consortium within last 10 (Ten) years from the date of tender opening. The tenderer (any of the partner in case of Joint Venture) must have the experience of construction, fabrication and commissioning of 1 (one) CGS/TBS/High Pressure RMS (Minimum inlet pressure = 300 psig) within last 10 (Ten) years from the date of tender opening. For river crossing by HDD (Horizontal Directional Drilling) method, the Tenderer may engage subcontractor who must have experience of engineering, procurement, construction, testing and commissioning of at least 1 (one) river crossing of 8" or higher diameter and width minimum 500 meter (bank to bank) by HDD method within last 10 (Ten) years from the date of tender opening. As evidence of experience, the Tenderer must submit completion certificate of river crossing by HDD method, pipeline construction by PC (Procurement and construction) and construction of M & R station.
