This is an online Tender, where only e-Tender will be accepted in the National e-GP Portal and no offline/ hard copies will be accepted. To submit e-Tender, registration the National e-GP System Portal (http://www.eprocure.gov.bd) is required.

The fees for downloading the e-Tender documents from the National e-GP System Portal have to be deposited online through any e-GP registered banks branches up to 04.02.2020 at 17.00 PM. Notice that according to ITT Clause No-4.2 maximum quantity of incomplete lines for BREB Enlisted Line Construction Contractors (LC) - Up to 300 KM, BREB Enlisted Provisional Line Construction Contractor (PLC) - Up to 100 KM, PBS Enlisted Permanent Mini Contractor - Up to 100 KM and PBS Enlisted Provisional Mini Contractor - Up to 100 KM are eligible and Tenderer who have not more than 02 (Two) contracts of the Line construction at off-grid area are eligible. In both cases over is not eligible. Also according to ITT Clause No-15(i) Interested Contractors must visit the construction site of the offgrid Area before submission of Tender and must submit "Declaration of Site Visit" and "Declaration of Incomplete line" on the letterhead Firm. Otherwise Tender may be rejected.
