
This is to inform you that you have signed above mentioned contracts with URIDS (RRKB) & URIDS (DMCS) projects of BREB to supply conductor accessories and guy accessories. Among the supplied materials guy accessories (E-21, E-22, E-23) was found non-complied with the specification of the contracts. BREB has requested you several times to replace the said materials but you did not replace the non-complied materials as per contract. Besides that, as per your commitment you did not submit the BankGuarantees against replacement of the non-complied materials. For that reason Bangladesh Rural Electrification Board (BREB) has been compelled to take the following decisions on 644th Board meeting against your firm:

- (a) M/s. KSE Electricals Pvt. Ltd., India is debarred/blacklisted for future participation to all kinds of tender as Bidder, Manufacturer and as in any other name in BREB until the proposed Arbitration has been successfully settled or BREB's claimed amounts have been deposited for the non-complied materials (E-21, E-22, E-23) among the supplied goods as per agreement against 4 contracts (Contract no. BREB/URIDS(RRKB)/URIDS(W)-G-03-01/2017-2018; Dated: 19-10-2017, BREB/URIDS(RRKB)/URIDS(W)-G-12-03/2017-2018; Dated: 14-02-2018, BREB/URIDS(DMCS)/URIDS(E)-G-03-01/2016-2017 Date: 18.09.2017 BREB/URIDS(DMCS)/URIDS(E)-G-14-01/2017-2018 Date: 27.12.2017 for procurement of conductor accessories and guy accessories), for not submitting

Bank Guarantees as per negotiation meeting's decision (held on 23/12/2020) after final notice and due to breach of contract terms and conditions under "Up-gradation Rehabilitation and Intensification of Distribution System (Rajshahi, Rangpur, Khulna and Barisal Divisions) (2nd Revised)" and "Up-gradation Rehabilitation and Intensification of Distribution System (Dhaka, Mymensingh, Chittagong and Sylhet) (2nd Revised)" projects financed by ADB, GOB and BREB.

- (b) It will be considered to withdraw M/s. KSE Electricals Pvt. Ltd., India from the debar/ blacklist for participating to all kinds of tender as Bidder, Manufacturer and as in any other name in BREB after successful settlement of the proposed Arbitration or BREB's claimed amount have been deposited.

This is for your kind acknowledgement and to take necessary action as per BREB board decision.


