Notice that according to ITT Clause No-4.2 maximum quantity of incomplete lines for BREB Enlisted Line Construction Contractors (LC) - Up to 300 KM , BREB Enlisted Provisional Line Construction Contractor (PLC) - Up to 100 KM , PBS Enlisted Permanent Mini Contractor - Up to 100 KM and PBS Enlisted Provisional Mini Contractor - Up to 100 KM are eligible and over is not eligible. Also according to ITT Clause No-15(i) required information must be fill up in prescribed Table. Otherwise submitted tender will not be considered for evaluation.
