SUBJECT: WORKMEN,S COMPENSATION BENEFIT SCHEME FOR THE PBS.

PURPOSE:

To provide guideline for the Workmen's Compensation Benefit Scheme to be utilized by the Palli Bidyut Samities.

POLICY:

Each PBS will adopt the Workmen's Benefit Scheme within the guidelines as laid down in this Instruction.

GUIDELINES:

The Palli Bidyut Samities are entrusted with the prime responsibility for construction, operation, distribution and maintenance of electricity in the rural areas. Some employees are entrusted with the responsibility to implement this system. As they face professional hazards, the PBS in liable under this instruction to pay compensation (as per schedule-11) to an employee for death, and permanent disablement or partial disablement caused by accident or statutory disease arising out of or in course of employment:

Provided that the PBS shall not be so liable—

in respect of any injury which does not result in the total or partial disablement of the employee/workman for a period exceeding four days;

- the employee/workman having been at the time thereof under the (i) influence of drink of drugs, or
- the willful disobedience of the employee/workman to an order expressly given, or to a rule expressly framed, for the purpose of securing the safety of employee/workman, or
- (iii) the willful removal or disregard by the employee/workman of any safety guard or other device which he knew to have been provided for the purpose of securing the safety of employee/workman.

ARRANGEMENTS OF FUNDS AND PAYMENTS

- 1) The PBS will open a Savings Account and will deposit monthly to this account 1% (one percent) of the Base pay of the employees covered under Schedule-1. The amount accumulated in this Fund over Taka 2,00,000.00 (Two Lac) will be invested in Fixed Deposits (FDR) amounting to Taka 1,00,000.00 (One Lac) each. The final balance will be Taka 5,00,000.00 (five Lac) for every fifty Concern employees, subject to the maximum of Taka 50,00,000.00 (fifty Lac).
- 2) When the maximum fund balance has been achieved, no additional deposits will be required until benefits are paid out of it, then deposit will be required again until the fund reaches the maximum balance. The interest earned, after the target is achieved, will be deposited into the General Fund of the PBS.

Subsequently, the General fund will be reimbursed as soon as the Benefit Scheme Fund attains sufficiency.
- 4) The PBS Board of Directors will appoint the following committee along with one (1) representative from the PBS Board who will be responsible for the management of this Benefit Scheme. After examining the terms and conditions of the Benefit Scheme committee will provide their recommendations. The recommendations will be approved by the PBS board.
