PURPOSE:

To set forth the terms and conditions for providing electric service connection for the premises of household, commercial, industry, bridge, fly over, power plant, etc. under construction.

POLICY:

PBS will provide electric service facilities to the construction area of Household, Commercial, Industry, Bridge, Fly Over, Power Plant, Etc. under the following terms and conditions:

Submission of Application: A.

The consumer shall submit an application requesting a permanent electric service connection, specifying the time (month and year) when the connection would be taken, and stating the estimated load to be used by the above user. He will also mention his Construction load requirement during the construction period. On that basis, Consumer will sign an agreement with the PBS (as per attached appendix) keeping in view the PBS Instruction 300-4, 300-37, 100-35, 100-42 etc. according to BERC rate schedule/ Tariff order.

B. Building of Permanent Line Facilities:

On the basis of declared load to be used by the Industry the PBS will extend service facilities on permanent basis up to the sub-station point of the consumer and therefore provisional connection will be given provided the provisional load, the line is to be constructed on deposit work. At the time of permanent connection, the deposited amount (line construction cost) will be adjusted against the monthly energy bill.

C. Requirements During provisional Connection period:

PBS will provide service facilities as per declared provisional load subject to strict compliance of the followings:

1. Contract Period:

Period of such contract will be limited to a maximum period of two years which may, however, be sparingly extended on a case-to-case basis for any further of time by the Bangladesh Rural Electrification Board on the recommendation of the Samity Board based on genuine and well-established grounds which are in their opinions, beyond the control of the consumer.

2. Supply Of Transformer:

PBS will supply Transformer for the provisional connection period subject to realization of the following charges:

a) The consumer will pay, in advance, the Transformer cost and an installation and removal charge of Tk.2,000.00 (Taka Two thousand) for single phase and Tk. 4,000.00 (Taka four thousand) only for three phase transformer bank.

3. Capacity Of Transformer:

Maximum Transformer capacity for provisional connection shall be as per consumer requirement.

4. <u>Damage or stolen Cases:</u>

It is to be mentioned in the Agreement that the materials or

equipment used for the purpose of provisional connection by PBS, if lost or damaged or stolen, the entire cost of the same will be realized from the consumer before re- connection.

5. Energy rate and Demand charge:

The Rate Schedule under this category will be the following:

LT- C 2: The consumers of Household, Commercial, Industry, Bridge, Fly Over, Power Plant, etc. upto 50 KW will be under this Rate Schedule category.

MT- 4: The consumers of above 50 KW up to 5 MW load will be under the category of MT- 4 as per approved load demand.

HT- 4: The consumers of above 5 MW up to 30 MW load will be under the category of HT- 4 as per approved load demand.

Security Deposit:

The consumer will pay in addition to all charges anadvance security deposit on provisional load (required during construction period only) and this will be calculated as per BERC Rule. If the consumer fails to taka permanent connection by supplying his own transformer as per declared load within the stipulated period, the entire advance deposit, will be forfeited and the connection will be disconnected.

7. Adjustments of Advances:

Payment of advances and dues from the consumer to the PBS and vice versa are subject to final adjustment on the basis of actual consumption and cost incurred.

8. Capacity retention charges:

The consumer will have to pay the capacity retention charge, as calculated according to 300-04, until permanent connection is made.

Agreement for provisional Electric Service (Under Construction Industry)

Agreement Palli Bidyut Samity (hereinafter called the "PBS"), and(hereinafter called the "Consumer") a(Corporation, Partnership or individual)
The PBS will sell and deliver to the consumer, and the consumer shall purchase all Electric power and energy which the consumer may need at the location described in Exhibit "A", attached hereto and by this reference made a part hereof upon the following terms and conditions:
1. Service Characteristics and Conditions:
(a) Service hereunder shall be alternating current volts. Provisional load kw (kva X 0.95)
(b) Service hereunder shall be furnished on a Provisional basis not to exceed twenty four (24) months durations, beginning with the initial billing period following the date PBS first makes Service available.
(c) Service hereunder shall be furnished on basis of Consumer's declared load requirements of the under construction industry, with permanent electric facilities being extended up to the consumer designated sub- station location.

2. Payment:

- (b) The initial billing period shall start when Consumer begins using electric power and energy, or seven (7) days after the PBS notifies the Consumer in writing that service is available hereunder, whichever shall occur first.

3. Membership:

The Consumer shall become a member of the PBS, shall pay the membership fee and be bound by all provisions of the articles of Incorporation and By-Laws of the PBS and by such rules, regulations and rates as may from time to time be adopted by the PBS.

4. Continuity of Service:

The PBS shall use reasonable diligence to provide a constant and uninterrupted supply of electric power and energy. However if such supply should fail or be interrupted or becomes defective through an act of God, Governmental authority, action of the element public enemy, accident, strikes, labor trouble, load shedding, required maintenance work, in ability to secure Right-off-way or any other causes beyond the reasonable control of the PBS the PBS shall not be liable thereof or for damages caused there of or for damages caused thereby under the provisions of the Agreement.

5. Right of Access:

Duly authorize representatives of the PBS shall be permitted to enter the Consumer's premises at reasonable times in order to carry out the provisions hereof.

Succession:

This agreement shall be binding upon and inure to the benefit of the successors, legal representatives and assignee of the respective parties hereto.

8. Construction Cost:

The Consumer shall pay to the PBS a sum of Tk......on account of Line construction cost for permanent facilities to make service available to the Consumer. This amount must be paid to the PBS before commencement of construction of such facilities. No refund shall be made to the Consumer of any portion of the given money for the Construction.

9. Deposit:

The Consumer,in addition to making payment of all charges specified elsewhere in this Agreement and all other relevant PBS Policy Instruction, shall deposit with the PBS the sum of Tk....being a refundable
